The undersigned herein after called Applicant hereby applies for membership in and agrees to purchase electric energy from Mountain Electric Cooperative Inc. and to that end agrees to comply with and be bound by the Articles of Incorporation of Cooperative, the By-Laws of Cooperative and any amendments thereto, and such Rules and Regulations as may be adopted from time to time by Cooperative.

- Applicant agrees when electric service becomes available that all electric energy used on the premise will be paid therefore monthly at rates to be determined from time to time in accordance with the By-Laws of Cooperative; provided however, that a minimum bill will be paid each month regardless of the number of kilowatt hours consumed.
- Applicant agrees: a. to make payment of such fee as is designated in the By-Laws of Cooperative in respect to membership.  
b. to make payment of such fees as is designated in the Rules and Regulations which are incidental to providing electric energy at the service connection.  
c. that any fees specified in (a) shall be refundable except in the event that the applicant fails to fulfill his contract with the Cooperative as provided in the By-Laws.
- Applicant agrees to deposit with the Cooperative such consumers deposit as is required by the Rules and Regulations of Cooperative; it being expressly understood that such deposit shall be non-interest-bearing and that any portion of said deposit not applied to the payment of bills due Cooperative shall be refunded to applicant upon termination of service.
- The acceptance of this application by Cooperative shall:
  - Constitute a contract for electric service between Applicant and Cooperative which shall continue in force until cancelled by at least 10 days written notice by either party to the other.
  - Constitute an acceptance by applicant to membership in cooperative with such rights and liabilities as are specified in the By-Laws of the Cooperative provided however that said membership shall terminate when applicant ceases to purchase electric energy from Cooperative.
- Applicant agrees to grant to the Cooperative as a condition of membership an easement or right-of-way over, on and under all lands owned, leased or mortgaged by the member on such reasonable terms and conditions as the Cooperative shall require for furnishing of electric service to the member or to any other members and for the construction, operation, maintenance, and relocation of electric facilities. A member shall execute and deliver to the Cooperative such specific written grants or easement as may be required by the cooperative.
- Applicant is accepted as a member of the Cooperative, hereby authorizes Cooperative, upon termination of membership in any manner to cancel said membership, and it is understood that after termination of membership Applicant agrees to pay all accumulated bills and legal fees necessary for the collection of unpaid accounts.
- Applicant by becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative.

All meter hubs must be properly marked (e.g., apartment number, lot number, street number. Etc.) MEC is not responsible for marking meter hubs. Meters will not be set in meter hubs that are known to be incorrectly marked or unmarked. The residence main breaker should be in the off position before the meter can be set.
